Read: Notification of NCTE, New Delhi dated 1.1.2004 published in the Gazette of Indi Part III-Section 4 as No. 3 on 5.1.2004.

The NCTE, New Delhi in its Notification dated 01.01.2004 decided to dispense with the requirement of "No Objection Certificate" from State/UT Government for those institutions already running Elementary programmes recognized by NCTE and seeking. recognition to start a course or training in increase in intake for a period of three years from the date of notification of these regulations in the Official Gazette.

Avinasi Gounder Mariammal Trust Teacher Training Institute, Karur Bye Pass Road, Kollampalayam, Erode Dist. - 638 002, Tamilnadu which has been granted recognition by SRC-NCTE has submitted an application for increase in intake for Elementary (D.T.Ed) course by deriving the benefit of above said regulation on 10.11.2004.

The application for increase in intake of Avinasi Gounder Mariammal Trust Teacher Training Institute, Karur Bye Pass Road, Kollampalayam, Erode Dist. - 638 002, Tamilnadu was considered by SRC-NCTE under section 15 of NCTE Act, 1993. Accordingly, inspection of the institution was carried out on 4.6.2005 and the report of inspection team and other documents furnished by the institution along with the application were considered by the Southern Regional Committee in its 97th meeting held on 27th July, 2005.
